INTRODUCTION

OUTER SPACE WRLD cares about your privacy and security and will always process and use information about you in a safe manner. In this Privacy Statement we explain which data we process and for which purpose we do this. WHO IS OUTER SPACE WRLD?

OUTER SPACE WRLD is the sole proprietorship OUTER SPACE WRLD, registered in the trade register of the Chamber of Commerce under the number xxxx. OUTER SPACE WRLD is responsible for handling and processing your personal data.

HOW DOES OUTER SPACE WRLD USE YOUR DATA?

MARKETING

Purpose: Performing direct marketing

Data: Name, email address, phone number, click behavior, interest in a product, social media account, order history

Basis: Legitimate interest

Retention period: As long as necessary to complete this purpose

Purpose: Performing affiliate marketing

Data: Name, email address, phone number, click behavior, interest in a product, social media account, order history

Basis: Legitimate interest

Retention period: As long as necessary to complete this purpose

Purpose: Performing social media marketing

Data: Name, email address, phone number, click behavior, interest in a product, social media account, order history

Basis: Legitimate interest

Retention period: As long as necessary to complete this purpose

Purpose: Performing behavioural targeting

Data: Name, email address, phone number, click behavior, interest in a product, social media account, order history

Basis: Legitimate interest

Retention period: As long as necessary to complete this purpose

Purpose: Sharing news letter

Data: Name, email address, phone number, click behavior, interest in a product, social media account, order history

Basis: Legitimate interest

Retention period: As long as the customer agrees to the use of the above mentioned data to complete this purpose

WEBSITE

Purpose: Use of website analytics

Data: Surfing behavior, user profile, location

Basis: Legitimate interest

Retention period: As long as necessary to complete this purpose

HOW DO WE OBTAIN YOUR PERSONAL DATA?

All personal data used by OUTER SPACE WRLD are provided by the customer.

WHAT ARE YOUR RIGHTS?

Under the European General Data Protection Regulation, you have a number of rights with regard to your data and its processing, of which the following:

INSIGHT

You can view your own personal data at any time and change them in your account if necessary. If you want to see the personal data have been registered from you at OUTER SPACE WRLD, you can request access from OUTER SPACE WRLD.

MODIFY

If you want to make changes to your personal data, as registered by OUTER SPACE WRLD, and you are unable to change them in your account yourself, you can request this from OUTER SPACE WRLD. You can request OUTER SPACE WRLD to change, correct, supplement or delete your personal data.

RESTRICT PROCESSING

You have the right to request the restriction or suppression of their personal data. This is not an absolute right and only applies in certain circumstances. When processing is restricted, OUTER SPACE WRLD is permitted to store the personal data, but not use it.

DATA TRANSFER

You have the right to obtain your personal data from OUTER SPACE WRLD. OUTER SPACE WRLD will provide these in a structured and common form, which can easily be opened in other common digital systems.

WITHDRAWAL OF CONSENT

In all cases where the basis for a certain data processing is your consent, you have the right to withdraw that consent. This has no consequences for the past, but does mean that we may no longer process these particular data in the future. It is possible that from that moment on OUTER SPACE WRLD can no longer provide you certain services. A request to revoke consent can be sent to info@outerspacewrl.com. OUTER SPACE WRLD will settle your request as soon as possible and in any case no later than one (1) month after OUTER SPACE WRLD has received the request.

RECIPIENTS OF PERSONAL DATA

Personal data can be shared with:

- Processors
- Third parties involved in the performance of an agreement between you and OUTER SPACE WRLD. It is possible that OUTER SPACE WRLD is obliged to provide your data to a third party, for example on the basis of a legal obligation.
